- Participated in and supported 4H and Boy Scout activities in the park.
- Helped with interpretive signs in the park and Albertson Parkway.

At our monthly meeting (documenting on our website and newsletter) we plan and take actions to address important issues and needs, e.g.:

- How to get more families to participate in our **Health and Wellness** exercise events. We plan and lead monthly outdoor hikes as part of Kaiser's/County Parks' Healthy Trails program, and special events. e.g.: our History Hike.
- How to work with public officials to find solutions to **Neighborhood Security, Safety, Beautification, Interest, and Pride**. Our members work with public agencies to support neighborhood clean-up projects, reporting and fixing vandalism, blight, hazards, and other issues.
- How to expand the community's **Cultural Education** knowledge of our neighborhood's natural environment and historical culture by using Santa Teresa Park as a living classroom. We plan sponsor a musical presentation at Fandango, which is a cultural event, using entertainment to expose residents to music of the Rancho era.

### Implementation\*

- **Meetings:** Since 1992, members of our community have come to discuss neighborhood **safety** issues at our meetings. We discuss, plan, and resolve methods to address them. We have been successfully encouraging more patrols by police, rangers, and sheriff's deputies. We have developed a Neighborhood Park Watch program to help assist our local safety officers. We invite park officials to our meetings to discuss our concerns and news. We are planning a beautification project for the lot across from Bernal School. Our board is responsible for conducting the meetings. UNSCC membership insures our meetings.
- **Website:** We are requesting funding for our website, where we keep the community **engaged**, and informed. Our secretary is the webmaster for managing our website. We publish our meeting minutes, events calendar, park and neighborhood news, special reports, important neighborhood issues, as well as their progress and resolution.. <http://www.stpfriends.org/>
- **History Hike Event:** This will bring our community together for an educational event and nature hike, with talks and skits on local historical events and nature displays and craft activities. Our president, who has taught California history, has written books on local history, and has led many **engaging** historical tours, will be leading this walk, along with assistance of other members. - **Newsletter:** We are requesting funding to publish a newsletter, which we will pass out at community events, such as the annual Santa Teresa Community Festival. Besides announcing our meetings, website, and events, it will

have articles about the park to encourage people to use, visit, and hike the trails in the park. Also, it will discuss the history of the park and historical points of interest to **engage** and develop pride in the neighborhood. This will be a group effort, with articles written by our members. Our secretary will serve as the editor.

- **Fandango Entertainment:** This is the largest event at Santa Teresa Park. The event has historical and cultural displays, activities, and talks. We plan to partner with the County Parks and Recreation Department to sponsor entertainment that will **engage** and draw the community to the event, but is also appropriate to its theme and adds to it.
